## Inflatable Bounces-Inflatable Rides/Games

### Rental Agreement, Release And Assumption of Risks

#### Terms & Conditions/Warranty:

1. At the time of accepting delivery of rented items/equipment, the customer agrees to all of the written terms and conditions on this rental contract. The customer also acknowledges that he/she is at least 18 years of age and agrees that they have received all of the rental items on their contract in good order.
2. Customer agrees to assume full responsibility for all of the rented items during the period of time in which the rentals are in their possession including safe and proper use, operation, maintenance and return to The Party Man. Customer is fully responsible for all loss, damage or repair.
3. Recovery of Equipment: If customer fails to return all rented items by the agreed time, then the customer agrees to pay for any additional charges that are incurred as a result. If customer refuses to return the rental items back to The Party Man, then the customer agrees that The Party Man, and it's agents will take all reasonable actions needed in order to recover the rented items without legal process or advance notification.

#### Release of Liability:

4. Duty of Participants-It is recognized and understand that some of the activities offered and conducted by The Party Man can be hazardous to the participants regardless of all possible safety measures that can be taken. All participants have a duty to act responsible and prudent while engaging in the recreational activities which are provided by The Party Man. **I hereby agree NOT to do the following:**
  - A. Act in any manner which shall interfere with the operation of any ride, inflatable or game, as well as any other activity or equipment that is provided by The Party Man when all of the activities conform to the rules & regulations provided by the state of PA.
  - B. Engage in any conduct that willfully or negligently contributes or causes injury to any person(s).
  - C. To embark in any self initiated activity without first informing The Party Man of your intentions, and also receiving permission from The Party Man to engage in such self initiated activity.
5. I understand and acknowledge that the activity which I am about to voluntarily participate in bears certain known risks and possible unanticipated risks which include and are not limited to the following... slipping, crashing, falling and colliding and could result in illness, injury, emotional distress, disease and or property damage to myself or anyone of my guests/invitees.
6. In consideration of the services and property provided, I not only for myself, but also for any minor children for which I am the parent, legal guardian or otherwise responsible, any heirs, personal representatives or assign, do hereby release and hold harmless The Party Man, it's agents, employees, volunteers and anyone else of affiliation from any liability and waive any claim from damages or injury that may arise from any cause whatsoever.

7. Lessee agrees to supervise both the equipment and its use at all times said equipment is in the possession of the lessee. Accompanying this contract is a set of directions for use, along with safety rules that I agree to utilize and follow at all times during the operation of the ride, inflatable, game or any other piece of equipment that was rented from The Party Man.

I agree to the following rules and operating instructions:

**Safety Rules and Operating Instructions:**

1. A trained operator(s) must be on duty at all times.
2. Ensure that all of safety rules and operating instructions that are posted on the front of the inflatable, as well as any written and/or verbal instruction that were provided are all followed.
3. In the case of high winds of 15 mph or stronger, or any other potentially dangerous inclement weather, have all persons exit the inflatable or ride, then unplug the unit to let it deflate.
4. Remove all sharp or pointy objects from pockets. For example: all jewelry, cell phones, keys, pens, pencils etc.
5. No food, drink or gum allowed on the rides or inflatables.
6. Remove shoes, pens, pencils, earrings, eyeglasses, cell phones, rings and jewelry.
7. **NO SILLY STRING** is permitted to come in contact with either the inside or the outside of any of the rental units. If the inflatable is damaged as a result of **SILLY STRING then the customer agrees to replace/repair the damaged unit at cost.** A \$4,000 dollar fee will be imposed to replace or repair damaged rides, inflatables games and bounces. If the current replacement value of the rented equipment that is damaged exceeds the original \$4,000 fee, any additional fees beyond that will also be imposed on the client by signing this agreement.
8. Do not climb on the netting or the side walls of the rental unit.
9. Do not bounce near the entrance or up against the sidewalls. Also, do not bounce into corner posts.
10. Make sure the kids are a safe distance away from each other when they are participating on the rides, interactive games and bounces.
11. Do NOT jump off the top of the slide.
12. No jumping or sitting on the entrance ramp.
13. Make sure participants are of the same size when on an inflatable ride.
14. Follow the maximum number of riders and maximum weight limit posted on the inflatable.
15. Make sure the inflatable does not rub up against any other surface.
16. Once the bounce is set up by The Event Experts, Inc delivery team, it is NOT to be moved.
17. NO flips, somersaults, wrestling, pile up or rough play of any kind.
18. Those who are NOT permitted in the unit at any time are... those with head, neck or back injuries, disabilities, heart conditions, small infants, pregnant women and others who may be highly susceptible to injuries from bouncing, bumps and falling.

19. No water will be permitted inside or around the inflatable unless the unit was specifically manufactured with the intention of use with water.

20. If the inflatable starts to deflate, please have all of the riders exit the unit immediately, and then check the following...

A. Did the blower motor stop? If so, check the power cord connection to make sure it is still in place. If the power cord is in good standing, then check to make sure the circuit breaker was not tripped, or GFI outlet/receptacle was not tripped for any reason.

B. If the blower motor continues to run you want to check for a blockage of air intake on the side of the blower unit. Check all air tubes that are located on the back of the inflatable to ensure they are still snug. If needed, tighten the ties.

**If following step A or B remedies the situation... you can fully re-inflate the unit before allowing anyone to use it, and your guests can continue to use the equipment. If you cannot correct the problem, please call our emergency number that was provided to you at time of delivery or try contacting our office at 610-522-2725.**

I agree to follow and use these Safety Rules and Operating Instructions at all times during the term use and operation of all equipment. I am of at least 18 years of age as of today's date and fully consent to this agreement as it is written. I understand the risk of liability that is presented in renting the proposed equipment from The Party Man.

By signing this contract agreement, I hereby acknowledge and also certify that I have had sufficient time to thoroughly read this document in it's entirety. I fully understand all of it's contents and that I execute it intelligently, freely and without any duress. I agree to be bound by it's term, for the services being provided by The Party Man.
